

LOCAL REGULATIONS:

3. Seal.

3.1 The Associations seal will be kept at the offices of Kay, Shipley, McVey & Smith.

5. Expulsion of members and associate members.

5.1 A (d) If a member or associate member misses three consecutive regular meetings without being excused they may not be permitted to golf in the Annual G.P.P.A. Golf Tournament or may not be permitted to curl in the Annual G.P.P.A. Bonspiel.

6. Fees.

6.1 Annual G.P.P.A. membership fee will be \$60.00.

\$25.00 will be charged for meals served at General, Annual General, or Special meetings of the membership.

\$3.00 will be charged for alcoholic beverages served at the General, Annual General, or Special meetings of the membership.

A majority vote by the Membership will be required to implement any fee changes.

7. Visitors.

7.2 The Grande Prairie Petroleum Association welcomes invited guests to our general meetings. However, if a closed meeting is required and a visitor or visitors are going to be denied permission to attend, notice of same may be included in the newsletter mailed out to the membership preceding said meeting.

8. General and Annual General Meetings.

8.3 & 8.4 General meetings will be held on the third Thursday of each month, excluding July, August and December.

The November General and Annual General meeting will be combined, (General business addressed first followed by Annual business).

These meetings will currently be held in the Quality Hotel & Conference Center.

12.6 Other

(a) The Association's Executive may establish a special bank account for certain functions of the Association. Signing authority may be authorized for those special accounts to Association's members who are not on the Associations Executive but are chosen to chair the function in question.

(b) All cheques written on all of the Grande Prairie Petroleum Association's accounts need to be signed by two people having signing authority.
