Entry Eligibility Requirements

1 – Employees, officers or directors engaged full-time in petroleum exploration, drilling, development, production, refining, marketing, supportive services and supplies. These personnel must derive a minimum 65% of their earnings from the petroleum industry and have been employed by the industry for a minimum of three months  
2 – All local skips must be a member in good standing with the MPPA

3 – Entries must be received by March 08, 2024  
4 – Entry fee refunds will be made only on cancellations received by March 08, 2024  
5 – First 32 PAID rinks will be accepted  
6 – Four eligible curler names are required to validate entry  
7 – Donations are gladly accepted and will be acknowledged
